The essential elements of character building and ethics in sports are embodied in the concept of sportsmanship: trustworthiness, respect, responsibility, fairness, caring and good citizenship.

#### I therefore agree: (please initial each line)

	I will not force my child to participate in sports.
	I will remember that children participate to have fun and that the game is for the YOUTH.
	I will inform both PARPC and the coach of any disability or ailments that may affect my child
	or the safety of others.
	I (and my guests) will be a positive role model for my child and encourage sportsmanship by
	showing respect, courtesy and by demonstrating positive support for all players, coaches, officials, PARPC staff and spectators at every game, practice or other events.
	I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official,
	coach, player, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures.
	I (and my guests) will respect the officials and their authority during games and will not

	I will not encourage any behaviors/practices that would endanger the health/wellbeing of
	athletes.
	I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of the game or his/her performance.
	I will never ridicule or yell at my child, other participants or officials for making a mistake or
	losing a competition.
	I will emphasize skill development practices and how they benefit my child over winning and de-emphasize games and competition in the lower age groups.
	I will promote the emotional and physical well-being of the athletes ahead of any personal desire
	I may have for my child to win.
	I will demand an environment for my child that is free from drugs, tobacco, alcohol and will
	refrain from their use at all events.
_	I will refrain from coaching my child or other players during games and practices, unless I am
	one of the official coaches of the team.
