The essential elements of character building and ethics in sports are embodied in the concept of sportsmanship: trustworthiness, respect, responsibility, fairness, caring and good citizenship.

I therefore agree: (please initial each line)
I will not force my child to participate in sports.
I will remember that children participate to have fun and that the game is for the YOUTH.
I will inform both PARPC and the coach of any disability or ailments that may affect my
child or the safety of others.
 I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect, courtesy and by demonstrating positive support for all players, coaches, officials, PARPC staff and spectators at every game, practice or other events. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures. I (and my guests) will respect the officials and their authority during games and will not question, discuss, or confront coaches at the game, and will take time to speak with coaches at an agreed upon time and place.

I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of the game or his/her performance.
