FIELD TRIPS

Once per week we will be traveling offsite on a recreational field trip. Information regarding the destination, dates, and approximate times of departure/ return will be in our weekly newsletter and on the white board at the sign in table.

Camp shirts are to be worn on field trip days.

One optional field trip is planned. Sign-ups for optional field trip will take place at the front desk and may require a separate permission slip. Campers will not be visiting gift shops and do not need extra money to attend.

All transportation will be via busses driven by professional drivers. A Camp Director or PARPC Staff member will accompany the campers on each field trip.

Campers exhibiting signs of any illness causing symptoms such as red or runny eyes, 100+ fever, vomiting, cough, sore throat, shortness of breath, loss of taste or smell or diarrhea may not attend. If camper becomes ill you will be called and asked to pick up child immediately. A charge of \$20 per 5 minutes will be added to weekly tuition when child not picked up within 1 hour.



A LATE FEE of \$20 per five-minute increments will be charged when parent is later than 6:00 pm for pick-up. Time according to PARPC clock. Fee due with following week's tuition.



I have read, understand, and will promote PARPC's behavioral expectations with my child(ren).
