PARENTAL CODE OF CONDUCT

The essential elements of character building and ethics in sports are embodied in the concept of sportsmanship: trustworthiness, respect, responsibility, fairness, caring and good citizenship.

I will not force my child to participate in sports.
 I will remember that children participate to have fun and that the game is for the YOUTH.
 I will inform both PARPC and the coach of any disability or ailments that may affect my child
 or the safety of others.
I (and my guests) will be a positive role model for my child and encourage sportsmanship by
 showing respect, courtesy and by demonstrating positive support for all players, coaches, officials, PARPC staff and spectators at every game, practice or other events.
I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official,
 coach, player, or parent such as booing and taunting; refusing to shake hands; or using profane language or gestures.
 I (and my guests) will respect the officials and their authority during games and will not

 I will not encourage any behaviors/practices that would endanger the health/wellbeing of
 athletes.
 I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of the game or his/her performance.
I will never ridicule or yell at my child, other participants or officials for making a mistake or
 losing a competition.
 I will emphasize skill development practices and how they benefit my child over winning and de-emphasize games and competition in the lower age groups.
 I will promote the emotional and physical well-being of the athletes ahead of any personal desire I may have for my child to win.
 I will demand an environment for my child that is free from drugs, tobacco, alcohol and will refrain from their use at all events.
 I will refrain from coaching my child or other players during games and practices, unless I am
one of the official coaches of the team.

I also agree that if I fail to abide by the aforementioned rules and guidelines, I will be subject to disciplinary action that may include, but is not limited to the following:

- Verbal warning by official, head coach, and/or PARPC staff member
- Written warning
- Parent game suspension with written documentation of incident kept on file.

Palmyra Area Recreation and Parks Commission Participation Waiver for Communicable Diseases Including COVID-19

The COVID-19 pandemic has presented athletics across the world with a myriad of challenges. The COVID-19 virus is a highly contagious illness that primarily attacks the upper respiratory system. The virus that causes COVID-19 can infect people of all ages. Research from the Centers for Disease Control, among others, has found that while children do get infected by COVID-19, relatively few children with COVID-19 are hospitalized. However, some severe outcomes have been reported in children, and a child with a mild or even asymptomatic case of COVID-19 can spread the infection to others who may be far more vulnerable. While it is not possible to eliminate all risk of furthering the spread of COVID-19, the current science suggests there are many steps schools can take to reduce the risks to students, coaches, and their families.

The PARPC will take the necessary precautions and recommendations from the federal, state, and local governments, CDC, PA DOH, WHO, as well as the NFHS and PIAA. The PARPC realizes the knowledge regarding COVID-19 is constantly changing as new information and treatments become available. These recommendations will be adjusted as needed and as new information becomes available in order to decrease the risk of exposure for our staff, program participants, and spectators.

I understand that participating in athletic programs, events, and activities may include a possible exposure to a communicable disease including but not limited to MRSA, influenza, and COVID-19. While particular recommendations and personal discipline may reduce the risk, the risk of serious illness and death does exist. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of others, and assume full responsibility for my participation.
